The following rates, recently announced by the Department of Health and Human Services, reflect the premium, deductible and co-insurance amounts to be paid by Medicare beneficiaries in 2005:

| • | Co-insurance for Extended Hospital Stays | \$228 per day for days 61-90, \$456 per day for days 91-150 (In 2004, the figures were \$219 and \$438, respectively) |
| • | Co-insurance for Skilled Nursing Facility Stay | \$114 / day for days 21-100 (up from \$109.50 in 2004) |
| • | Monthly premium for disabled recipients under age 65 with less than 30 quarters of Medicare-covered employment | \$375 (up \$32 from 2004) |
| • | Monthly premium for seniors and certain disabled persons under age 65 with 30 to 39 quarters of Medicare-covered employment | \$206 |
